# INTRODUCTION



# Two Primary Objectives:

Provide **neutral**, **unbiased research** to help the region better understand the potential decisions and impacts of changes on winter access.

Explore other recreation access topics to benefit the region year-round in serving their guests.



# Five Linked Studies:

- 1) Local community survey of Cooke City, Silver Gate, Colter Pass, and Crandall Residents
- 2) Regional survey of Park County MT/WY Residents
- 3) Summer 2023 survey of Cooke City visitors
- 4) Winter 2024 survey of Cooke City visitors
- 5) Secondary analysis of economic impacts





- Sample sizes for each survey were strong.
  - A representative collection of responses was collected through all four surveys.
- The winter 2024 survey was delayed until enough snow was on the ground for visitors to be in the area.

Study Component	Sample Size
Local Community Survey (October 2023)	294 completed surveys
Regional Park County, MT/WY Survey (March/April 2024)	644 completed surveys
2023 Summer Visitor (August 2023)	728 completed surveys
2024 Winter Visitor (March 2024)	117 completed surveys






# What describes your residence in the Greater Cooke City Area?








# What are the biggest impacts or challenges affecting you in the Greater Cooke City Area?



# Based on hypothetical future scenarios, which scenario would you prefer for the Greater Cooke City Area for winter access on US 212 east of Cooke City?










# WINTER ACTIVITIES

When asked, "What kinds of winter activities will you participate in during this trip to Cooke City/Silver Gate area?" 85% of respondents (n=99) indicated snowmobiling, and were asked additional questions about their groups' snowmobile use.











# SUMMER TRIP CHARACTERISTICS

Is this your first visit to the Cooke City/Silver Gate area?








# **AWARENESS OF CURRENT ROAD ACCESS**

Are you aware that Highway 212 east of Cooke City is unplowed and closed to vehicle traffic during winter months?






# LIKELIHOOD TO VISIT COOKE CITY

# INTRODUCTION

# The purpose of this study phase is multi-faceted including:

- 1) To explore tourism spending by season using ITRR's comprehensive data;
- 2) To identify trends in resort and lodging tax data;
- 3) And, to use these data and the information garnered from the previous phases to build scenarios that explore how changes in recreational access impact the local area and beyond.

While much of the secondary data comes from Montana, Wyoming implications are also highlighted throughout using current research.

# 2022 PARK COUNTY NONRESIDENT TRAVELER EXPENDITURES & ECONOMIC CONTRIBUTION


- In 2022, nonresident visitors to Yellowstone Country spent an estimated \$337 million in the county, contributing \$396 million in total economic output.
- Park County ranked 6<sup>th</sup> in nonresident spending in 2022.







# QUARTERLY LODGING FACILITY USE TAX (4%) IN PARK COUNTY



- On average,
  51% of Park
  County bed tax
  is collected in
  the 3<sup>rd</sup> Quarter
  (July-Sept).
- On average,
   10% of Park
   County bed tax
   is collected in
   the 1<sup>st</sup> Quarter
   (Jan-Mar).

# **SCENARIO IMPACTS**

Scenario 1: Status Quo (No plowing)

# **Current Visitation:**

No change, expect 16% of total revenue to be collected in winter season.

# **New Visitation:**

Increasing potentially at an average rate of 1-2% but only from traditional markets.

Scenario 2:

Plowing WITHOUT any replacement trails/parking

**Current Visitation:** 

Net reduction of 20.5% of current winter visitors.

# **New Visitation:**

Additional visitors are likely from Park County, WY area. However, 3,000+ groups would be needed to offset losses.

Scenario 3:

Plowing WITH replacement trails/parking

**Current Visitation:** 

Net reduction of 2.5% of current winter visitors.

# **New Visitation:**

Additional visitors are likely from the Park County, WY area. Only 300 groups would be needed to offset losses.







# **KEY FINDINGS**



If changes are going to be made, all data points to opening Highway 212 WITH replacement trails and additional parking as the best solution forward.



<u>Protecting the winter experience</u> is very important. Failing to protect the winter experience will lead to a loss of current winter visitation.



Additional social and infrastructure considerations are needed with any option. (E.g., emergency services, road maintenance costs, etc.)





# **KEY FINDINGS**

Communication and PR around this topic is critical to convey the right message to visitors and residents.

Local business owners and those who live in Cooke City year-round have special considerations that should be considered when putting a plan into place.

This topic is difficult to navigate within the community, but there are areas of compromise.
